MEMBERSHIP HOLD

Six month or one year pre-paid members may place a hold/freeze on their memberships only if member will be out of the gym for a period of thirty (30) days or longer. Member must submit a written notice or email complete with anticipated dates of leave to Berkeley CrossFit (T2-PT, Inc.), PRIOR to leave, in order to freeze membership during this time. Hold will be effective immediately after notice is given.
